# Important information for members-

This summer members of the MG Andy Anderson ESC of MOAA met with QAC Commission asking that a 20% property tax credit approved by the commissioners in 2018 for over 65 retired military personnel of all branches set to expire in 2024 be extended. The commission led by commissioners Wilson & Moran unanimously approved Ordinance 23-04 that indefinitely extended the benefit to military retirees & was expanded to include "all veterans considered disabled by the Dept. of Veterans Affairs under 38 U.S.C. 1011 and in receipt of military compensation therefrom and shall include the surviving spouse."
