Induction of officers

HARFORD COUNTY PROPERTY TAX CREDIT

Harford County will provide a 20% tax credit for a maximum of 20 years, on county property taxes for individuals who are over 65 years of age, have a dwelling with an assessed value of \$600,000 or less, and who either own and have lived in the dwelling for at least 35 years or are a retiree or surviving spouse of a retiree of the United States' Uniformed Services who has not remarried.

This credit is also applicable to veterans or surviving spouses of veterans of the United States' Uniformed Services who have not remarried, who have a dwelling with an assessed value of \$600,000 or less and a permanent disability that is service-connected with a combined service-connected evaluation of 50% or higher that substantially limits one or more major life activities.

If you were approved for this tax credit last year you should have received a letter/form in the mail which you need to send in for renewal this year.

New Army App Will Offer Families the Latest Information on Their Communities

The Army is rolling out a new effort to deliver real-time information within its communities, acknowledging the longtime challenge of getting the word out.

The new app, called My Army Post, is being developed by soldiers for soldiers, family members, and Army civilians and designed to be local to their installation, said Army Chief of Staff Randy George at the Army Senior Leaders Town Hall during the 2023 Association of the United States Army (AUSA) Annual Meeting and Exposition. George, Army Secretary Christine Wormuth, and Sergeant Major of the Army Michael Weimer emphasized the importance of giving everyone on post information they need when they need it.

A reservist in the audience reflected a frustration common to military families when he said his wife would rather deal with their cable and internet provider than to try to get information from the Army.

"We have soldiers working on this right now," George responded. He then introduced a team of soldiers who are product engineers with the Army Software Factory in Austin, Texas, and working on the new mobile application.

The app will be developed in iterations, starting with Fort Cavazos and adapted to installations across the Army. It will provide real-time information on installation dining facilities, gyms, medical facilities, traffic at the installation gates, weather conditions, post-wide alerts, and other aspects of life on post. A key feature is a QR code and feedback tool allowing users to send notifications if information needs updating.

"One of the things that was really impressive to me," George said, giving an example of the app's capability, "[is if] you want to know what the gate hours are, it'll actually show you the gate, it'll show you how much traffic is at the gate."

Feedback is a priority for the app's continuing development, George said. The Army has been seeking comments from soldiers, spouses, and Department of the Army civilians and posted an online survey to learn what capabilities would improve readiness and make on-post life easier.

My Army Post is replacing the Army's Digital Garrison app. It is one of the newest among various types of apps that service branches offer; for example, Navy Region Southeast released in early 2023 its new installation-focused OneApp.

The Army's app is geared to providing "a single source of reliable, accurate, current information," Lt. Gen. Omar Jones, commander of Installation Management Command, said at another AUSA forum.

Information flow for families is a top priority for Sherrill Isenhower, volunteer coordinator for El Paso County and spouse of Maj. Gen. James Isenhower, commander of 1st Armored Division at Fort Bliss, Texas. As a

panelist at the forum focused on installation management, she noted the numerous ways leaders use to try to get messages out.

"The unveiling of this new app is going to be fantastic," she said.

Do Business Cards Still Matter?

Think about the last time you were at an event and collected a bunch of business cards. What did you do with them when you got home? Be honest.

My guess: Cards from people who you couldn't remember ended up in the trash, and you kept a few from people you planned to contact ... maybe the ones with a note or a star on the back as a reminder.

In a networking setting, the business card is a means to an end – connection. Whether you have a paper or digital business card matters a lot less than ensuring you have one. Your card is both a practical tool and a personal-professional branding medium.

Building a Better Card

Do not overthink your business card. Make it as user-friendly as possible. If you've decided to go the traditional, printed route, consider the following:

• Keep it simple. Your name, email, and phone number will suffice. Feel free to add your LinkedIn QR code or link, but avoid too much clutter.

• Finish strong. Use a matte finish, not a shiny gloss, so either you or your contact can make a note on the card without a smudge or an ink-stained finger.

• Stock options. Use a white or light-colored stock card – notes made by a blue or black pen should be easily readable.

• Include a rank? That's up to you. If you are targeting the defense sector, your rank can show you have experience in the industry. If you are not targeting that space, consider leaving it off. Still not sure? Consider making two sets – it won't break the bank!

Third Short-Term Funding Extension Will Keep Government Open Until March

President Joe Biden signed legislation Jan. 19 to temporarily extend federal funding into March, averting a partial government shutdown.

The House and Senate approved the continuing resolution in bipartisan votes after congressional leaders reached a broader agreement on spending levels through September 2024. The stopgap measure buys lawmakers additional time to finalize the \$1.59 trillion appropriations legislation and clear both chambers.

The continuing resolution finances federal operations at current levels through March 1 for most agencies and March 8 for others, including DoD. This marks the third short-term extension since September.

The latest continuing resolution staves off imminent funding disruption while negotiations proceed on the broader spending package. Lawmakers will utilize the coming weeks to translate the agreed budget framework into detailed appropriations language needed to keep the government running past March.

Congress must reach a funding deal by April 30 to avoid an automatic 1% across-the-board budget cut, as required by the Fiscal Responsibility Act passed in June 2023. MOAA urges all members to contact their lawmakers immediately and demand they finalize full-year appropriations to avert further disruption. Write your lawmakers today to make your voice heard – Congress needs to pass the funding bills our community relies
